



Internal Quality Assurance Cell (IQAC) is constituted with the primary responsibility of ensuring quality in curriculum, Teaching-Learning, Research, Infrastructure, Students support / progression, besides facilitating the institution to organize various activities.

#### 2022-2023

- IQAC conducted a webinar entitled "Practicum as a CIA Component." on May 27, 2022, Dr.A.THOLAPPAN, Associate Professor, Department of Education, Bharathidasan University, Trichy, addressed the teachers online and enlightened the audience about the inclusion of Practicum as one of the components of CIA.
- On November 4, 2022, a Faculty Development Programme on "NAAC SSR Preparation in a Nutshell," was conducted by the Department of Computer Science in Collaboration with IQAC. Dr. A. Venkatasan, Associate Professor of Physics at NMC in Puthanampatti, Trichy, gave the keynote address on the topic and enlightened the audience. 150 Teachers from various Departments participated and understood the key components of NAAC SSR preparation.
- On November 22, 2022, a seminar on "NAAC SSR Preparation" was conducted by IQAC, Dr. A. VENKATESAN, Associate Professor of Physics at NMC, Puthanampatti, Trichy, interacted with the teachers and dispelled the doubts surrounding the preparation of SSR.
- IQAC Students Chapter, motivated the science students to participate in "Poster Presentation" with relevance to the recent trends in their discipline on the National Science Day (28.02.2023).
- A mega Science exhibition was organized by Department of Physics, enlightening the students on alternate sources of energy, environmental issues etc.



- A magazine entitled "Physics Snippets 2023" was released by the Department of Physics on National Science Day.
- A sum of Rs. 30,17,360 was received as the first installment of DST-CURIE Project.
- NIRF report for the year 2023 was prepared and submitted to MHRD on January 9, 2023.
- > The AISHE report for the year 2023 was prepared and submitted to MHRD on February 13, 2023.
- The preparation of AQAR report for the academic year 2021–2022 got underway and all key indicators were addressed.
- Student Satisfactory Survey from Old students was gathered and displayed on the college website. The Google Form was used to collect the student's feedback.
- Students' feedback on the quality of education, planning, conduct of examinations and library facilities was collected and analyzed.
- The Upgradation of college website was kick-started collecting feedback from the teachers and other stakeholders.
